Judges CV's

Mr H Ogden: Howards first dog was a red Griffin called Copper, being his first dog he entered him in every class at an All Breed Championship Show. Copper was placed 4th out of 2 as the judge withheld the awards, but the same dog had the last laugh with 4 BOB at Crufts and became the breed record holder! Howard awards CC's over 4 Groups, in addition to being approved for the Toy and Utility at Championship level and has 63 credits over 6 Groups, being assessed by the KC's Judge Development Programme. He holds the distinction of youngest ever Crufts judge, Howard was 28yrs. A crime lawyer he used to represent those hauled up before the Kennel Club but is best know for representing a certain "Fred West"!!

Ms C Russell-Smith: (Llaneirwg/Argoell) Carrie came from a family of dog enthusiasts, started showing under her own kennel name "Llaneirwg" and her first judging appointment was in 1986. After showing, breeding and judging Newfoundlands to CC level, Carrie showed and bred Welsh Cardigan Corgi's in 1998 and awards CC's in this breed. Carrie spent 10 years with an International Dog Photographer which involved global travelling often taking dogs to show in Europe and the USA. She became acquainted with the English Toy Terrier, co-breeding a very successful litter resulting in one Am.Grand Ch and two Multi-Int.Ch.UK Ch. Offspring, their dam is Carries constant companion. Carrie has moved to Cornwall to be near her parents and sister and has an interest in Terrier and Lurcher racing. Carrie has judged at an All Breed Open level in the past 30 years Working, Pastoral, Utility, Toy, Hounds and Gundogs, All groups and Best In Show.

Mrs S MacBean: (Pryorvale) Suzanne has had West Highland White Terriers since 1992, she had success in breeding and showing, making up a Champion and getting four dogs in the Studbook. Suzanne has judged WHWT at Open and Limit Show level. She also has Norfolk Terriers and hopes to go further with them in the future.

Mrs M Murphy: (Berndrews) Michelle started in 1991 when given her first show Boxer "Berndrews Jiminey Cricket" her affix was first registered in 1972 by her grandmother, Margaret Brannigan and passed down to her in 2006. Michelle has owned and exhibited and shown Cocker Spaniels under her mum's affix "Lynshanes" for many years before her own affix. Michelle has attended Seminars: 2000/01, understanding The Boxer hosted by Miss Ann Ingram, The Boxer Heart hsoted by Dr Bruce Catternach and in 2013 completed under FCI Student Judges Education Seminar. She has judged Boxers in Ireland and the Scottish Boxer Club Open Show judging three Special Award Classes. Michelle and her husband imported in 2013 a Bernese Mountain Dog and also owns Flat Coated Retrievers and made up their first In.Ch in 2015.

REGULATIONS FOR THE PREPARATION OF DOGS FOR EXHIBITION F (Annex B)

- These regulations must be observed when a dog is prepared for exhibition and/or exhibited at any Kennel Club Licensed event. Objections may be referred to the General Committee for disciplinary action under these Show Regulations and/or for disciplinary action under Kennel Club Rule A11.
 - (a) A dog found to have been exhibited in breach of these Regulations will automatically be disqualified from exhibition at the show and from any award gained thereat.
 - (b) Unless the exhibitor provides a satisfactory explanation for the dog being exhibited in breach of these Regulations then he/she may be subject to further penalties of either a fine or as listed under Rule A11.
- (a) No substance which alters the natural colour, texture or body of the coat may be present in the dog's coat for any purpose at any time during the show. No substance which alters the natural colour of any external part of the dog may be present on the dog for any purpose at any time during the show.
 (b) Any other substance (other than water) which may be used in the preparation of a dog for exhibition must not be allowed to remain in the coat at the time of exhibition.
- 3. No act or operation which alters the natural conformation of a dog or any part thereof may be performed except:- (a) Operations certified to the satisfaction of the General Committee. (b) The removal of dew claws of any breed. (d) Operations to prevent breeding provided that such operations are notified to the Kennel Club before neutered dogs are shown. Nor must anything be done calculated in the opinion of the General Committee to deceive.
- 4. The General Committee without previous notice may order an examination of any dog or dogs at any show. Any examination thus ordered will be made by a person having executive authority who shall have a written directive from the K.C. in their possession. Samples may be taken for further examination and analysis.
- 5. An individual has the right to lodge an objection to a dog only if he/she is the owner or handler of a dog competing in the same breed or class. An objection may however, be lodged by an official of the show or by anyone so deputed by the Kennel Club. It will be the responsibility of the individual who lodges the objection or the official (as appropriate) to substantiate the grounds for the objection. The Kennel Club will substantiate the grounds for an objection made on its behalf.
- 6. Any objection by an individual related to an infringement of these Regulations must be made in writing to the Show Secretary at his/her office before the close of the Show & the individual must produce evidence of identity at the time of lodging the complaint.

Your dog is vulnerable and AT RISK if left in a vehicle in high temperatures and even on days considered as slightly warm. Please take care of your dog. If your dog is found to be at risk forcible entry to your vehicle may be necessary without liability for any damage caused.
